The HMKC agility program was started by Sue Erickson and Vicky Maclean. They commuted to Missoula every Friday for classes for about 2 months in about 1997 or 1998 and learned what they could. Then they decided they would build equipment for the club which was done in Sue and Gary's garage. Some of that original equipment is still around, I know I have the original tire jump at my home, out in the field. Anyone who has the pretty (and very heavy duty) wood jump wings has some of the original equipment. Vicky says that she remembers one of them testing out the A frame in Sue's driveway by climbing up on it and it promptly collapsed! The chains were too long and attached too high up! Vicky still has the original dog walk. Sue and Vicky started the beginner classes, they got people involved and attended every seminar they could and learned as they went along. We owe Vicky and Sue may thank you for introducing our membership to one of the very popular events in the dog performance world.

Our Club was founded in 1975 by a group of dedicated breeders of purebred dogs and dog show enthusiasts. A few of our founding members included Laurie Ekanger, Vicky Maclean, Adel Delp and Mary Blake. This original club membership established the foundation for the success and popularity of our cluster show. We carry on many of the show traditions they established. This same group established the obedience training program for the general community. For many years there were only 3 classes each year, it has now been expanded to meet the needs of our community with 8 to 10 obedience classes each year. We have also established a conformation/showmanship training session on Sunday afternoons where handlers of all experience level can practice and learn how to best present their purebred dogs. The agility events came into the world of dogs and basic obedience training proved valuable in this sport as well. *The club has gone through many changes over the years but at the core, the very reason this club exists is to promote quality breeding of dogs and the training of dogs, leading to a better quality of life for the dogs and owners*. Every member in this club is instrumental in the success of our club and your participation is ALWAYS appreciated. Without your participation this club will cease to exist.
