Did you know – This month I would like to highlight a few members and friends of the kennel club who have been very instrumental in the animal rescue cases over these past 13 years. Linda Owen and her sister Louise, Jeanette and Monique Prevel, Candy Kirby and several other friends of the kennel club were there to help all the Collies (about 180 dogs) in the Shelby rescue. They were also there to help all the Malamutes in the local Clancy rescue with well over 70 dogs. These ladies took time out of their everyday lives, for many months, to care for the dogs in these rescues; feeding, grooming, exercising and socializing. Working on these criminal case rescues is a delicate balance between caring for the animals and preserving the criminal evidence. It requires endurance and discipline; you have to keep secrets so as not to jeopardize the prosecution of the case. It requires compassion to focus on the dogs and their needs and to prepare them for adoption to their potential new homes. It requires self-sacrifice, taking time away from your own family and dogs. Here is a tid-bit that you may not know, here in Montana the county in which the rescue is housed endures the cost of that rescue and they usually do not have sufficient funds to cover that whole cost. So donations and contributions to those rescue

efforts are truly needed. Not everyone has the time and fortitude to work at a rescue, but one thing you can do is to encourage your national and local breed clubs to support these rescues.

The Oct Meeting - Again, we have a busy agenda for the meeting on Oct 4. I hope to see all of you. The big topic on the agenda will be the upcoming agility trial. Everyone in the club should be willing to help make this event a success. I am sure there are plenty of tasks that will be topics of conversation at the meeting. If you have never done these jobs before there will be guidance and training.
